Important Dates

- **Legal Team Registration Deadline on MTT: May 15, 2026** (Must have at least 6 players registered, and Credit Card Deposit/Team Agreement Form submitted via MTT)
- **Individual Early Entry Deadline: May 24, 2026** (Entry fees before this date will be \$43. Entry fees after this date will be \$60)
- **Individual Late Entry Deadline: May 28, 2026** (Registration fees after this date will increase to \$150 per player)
- **Schedule Posted: by May 22, 2026**

Registration

- Early entry fee: **\$43**; Late Entry Fee: **\$60**.
- All players must register for the Championship by clicking [HERE](#) for the Championship registration website, and then clicking on the Registration Link. If your team name does not appear in the dropdown menu on the registration form, please ask your captain to contact your Local League Coordinator to confirm your team's advancement.
- Players must be registered on both TennisLink for the local league roster and the USTA Tennessee State League Championship registration site using the Match Tennis App. Any player found to be competing in the Championship without having registered on both TennisLink and the Championship Website may be subject to disqualification and their matches being reversed.
- Players must be registered on both TennisLink for the local league roster and the USTA Tennessee State League Championship registration site Match Team Tennis. Any player found to be competing in the Championship without having registered on both TennisLink and MTT may be subject to disqualification and their matches being reversed.

Match Format

- 3 Doubles Matches
- Divisions: Men and Women 3.0, 3.5, 4.0

Match Tennis Team App

- Schedules online via the Match Tennis App are the official schedules.
- Scorecards will be submitted online using the Match Tennis Team app/portal. Only captains who are assigned the "captain" role in Match Tennis Team will be permitted to "Sign Off" and submit final scorecards for each match. Scores and results on TennisLink are the official results.
- After players are confirmed to be present and onsite by Site Directors, players will be assigned a court (via text) as they become available.
- Specific directions on how to use the Match Tennis Team App can be found on the Championship Website.

- All team matches will consist of three doubles matches.
- All individual matches will consist of the best two out of three sets, with a 10-point match tie break in lieu of a third set. Coman Tiebreak procedure will be in effect.
- In case of inclement weather, Championship Committee may use shortened scoring.
